Since 1990 the Great Lakes Ice Cream + Fast Food Association (GLIC+FFA) has sponsored the Ward J. Anderson Scholarship Program for your student employees. This next year, 2019, GLIC+FFA will award a total of \$4,000 in scholarship monies. Four (4) scholarships are available; one (1) \$2,000.00 scholarship, sponsored by GLIC+FFA, one (1) \$1,000.00 scholarship, sponsored by GLIC+FFA, and two (2) \$500 scholarships, sponsored by Taylor Freezer of Michigan.

To be eligible, student employees must:

- Be high school seniors through college seniors (their 4<sup>th</sup> year of college in a five-year program)
- Work a minimum of three (3) months for a GLIC+FFA member within this year
- A minimum 20 on the ACT composite or minimum 1,000 on the SAT
- A minimum 3.0 GPA at the time of applying
- Plan on attending a college, university, or an accredited trade school as a full-time student in the Fall of 2019

All eligible applications are read and scored by a committee of three (3) Board of Director members. The highest scoring applicant will receive the \$2,000.00 scholarship. The next highest scoring applicants will receive scholarships. In the event of a tie, a random drawing will be held to break the tie. Biographical information and photo is requested to use for press releases.

The Association will present certificates to the scholarship recipients and their sponsor at the Annual Convention in February. All scholarship winners are asked to personally accept their scholarship certificate at this time or to accept by a delegate (parent or employer) or video. Scholarship checks will be mailed to the recipient in May 2019.

There are several reasons for the scholarship program. This is a membership benefit to assist members in competing for the best employees in the labor market. The scholarship program will help deserving students meet college/trade school expenses. Finally, the Association and its members will receive a great deal of publicity and good will from the communities where we live.

To apply, fill out the application in ink or type. You may submit application to your school principal or counselor. Your school will provide the GPA and ACT or SAT scores, or attach a copy of your most recent transcript. Then mail application and required forms together in the same envelope. Three (3) complete sets (copies are acceptable) need to be submitted, with each set stapled together and mailed in one (1) envelope. In order to be considered, applications must be received by November 1, 2018. Applications are not accepted postage due. Be sure to allow sufficient time so the school can complete its requirements and meet our deadline. Selections are made mid-December and all applicants are notified of their status. Previous winners are not eligible.

The Great Lakes Ice Cream + Fast Food Association (GLIC+FFA) sponsors the Ward J. Anderson Scholarship Program for employees of its members. This next year, 2019, GLIC+FFA will award a total of \$4,000 in scholarship monies. Four (4) scholarships are available; one (1) \$2,000.00 scholarship, sponsored by GLIC+FFA, one (1) \$1,000.00 scholarship, sponsored by GLIC+FFA, and two (2) \$500 scholarships, sponsored by Taylor Freezer of Michigan.

In addition to having worked a minimum of three (3) months during the past year for a GLIC+FFA member, student employees must have a minimum GPA of 3.0, a minimum ACT composite score of 20, or minimum SAT score of 1,000, be high school seniors through college seniors (their 4<sup>th</sup> year of college in a five-year program), and plan to attend a college, university, or accredited trade school as a full time student in the Fall of 2019.

Because the GPA is an important eligibility requirement, it's essential that the GPA be computed uniformly. We are using a 4.00 for the top grade. If your school uses 4.40 for an A+, or weights the GPA for honor classes, please adjust the GPA to 4.00 for the top grade.

Application and required forms must be completed in ink or typed, mailed together in one (1) envelope, and received by November 1, 2018. Three (3) complete sets (copies are acceptable) need to be submitted, with each set stapled together and mailed in one (1) envelope. Applications are not accepted postage due. Selections are made mid-December and all applicants are notified of their status. The Association will present certificates to the recipients and their sponsors at the Annual Convention in February. Scholarship checks are mailed to the recipient in May 2019. Previous winners are not eligible.
